## CANADA-JORDAN FREE TRADE AGREEMENT (CJFTA) RULES OF ORIGIN

### In Brief

The editing revisions made in this memorandum do not affect or change any of the existing policies or procedures.

This memorandum provides a stable link to the Department of Justice for the official version of the [CJFTA Rules of Origin Regulations](#) that are used to determine the entitlement of goods to preferential tariff treatment under the Canada-Jordan Free Trade Agreement (CJFTA).

### Legislation

#### [CJFTA Rules of Origin Regulations](#)

##### Rules of Origin

1. The following provisions of the Free Trade Agreement between Canada and the Hashemite Kingdom of Jordan, signed on June 28, 2009, have the force of law in Canada:

- (a) Articles 4-1 and 4-2;
- (b) Article 4-3, paragraph 1;
- (c) Articles 4-4 to 4-13;
- (d) Article 4-15; and
- (e) Annex 4-1.

##### Coming Into Force

2. These Regulations come into force on the day on which section 32 of the [Canada-Jordan Economic Growth and Prosperity Act](#), chapter 18 of the Statutes of Canada, 2012, comes into force.
